### Position Overview –

In conjunction with the Medical Director and Executive Director, the Nurse Manager is responsible for overseeing, implementing, and maintaining the quality of services provided by the clinic to remain fully compliant with California State Licensing regulations. Implements, maintains, and conducts annual review of the clinic's medical policies and procedures approved by the Medical Director. Strongly advocates for the highest quality of medical, psychosocial and spiritual care services provided by CNWRC to the local community. Provides patient care and ultrasounds as needed.
